

# COOKIES POLICY

The user is advised that this website uses its own cookies and third-party cookies and/or similar technologies.

## 1) **What are cookies and/or similar technologies?**

This website uses cookies and/or similar technologies (hereinafter, "cookies").

Cookies are small blocks of information that store and retrieve information from your device when you browse a website to, for example, remember certain aspects of your last content search so that subsequent searches are faster. The types of cookies we use and their purposes are specified in section 3 of this Cookies Policy.

We use both *session cookies*, designed to collect and store data only while you access this website, and *persistent cookies*, in which the data collected are kept stored in your terminal and which we may access for the time defined in section 5 of this Cookies Policy.

We remind you that you can set your cookie preferences at any time through the [Cookies Manager](#).

## 2) **Who manages cookies?**

We inform you that this web portal uses proprietary cookies. The company of the ISDIN Group that owns the website is responsible for the information included in these cookies.

It also uses *third-party cookies*. Third parties outside Isdin are responsible for the information included in these cookies.

In the following section, we will inform you about who manages cookies in each case, depending on their type and purpose. Additionally, you can check and configure the list of cookies used on this website at any time, as well as whether they are proprietary or third-party cookies (and identify the third party hired or whose services will be used), and their purpose, through the [Cookies Manager](#).

## 3) **What types of cookies do we use and for what purposes?**

This website uses the following cookies:

- *Technical Cookies*

Technical cookies are essential for the proper functioning of the website and for the use of the different options or services that we offer you through it (for example, to identify the session or use security elements during browsing).

Technical cookies may be owned by Isdin or third parties and cannot be uninstalled, because their disabling prevents the correct functioning of the website.

- *Preference Cookies*

Preference or functionality cookies enable the website to provide you with better functionality and personalisation, helping to remember information you have selected to access the service with certain features that differentiate your experience from that of other users (for example, language selection, country, or results we display when you perform a search).

Functionality cookies may be owned by Isdin or third parties and you can configure them at any time through the Cookies Manager. If you do not allow them, some of the functionalities or services of the website may not function properly.

- *Statistical Cookies*

We also use statistical or measurement cookies, which collect information about the behaviour of users during browsing (for example, the most visited pages) and allow us to know how they interact on the website.

Their purpose is to measure the activity of our website to introduce improvements based on analysis of data on the use of our website by users. To do this, website trend reports are prepared, without identifying users individually.

In order to compile statistics on the use of our website, we use tools with a scope limited to the functions described in the previous paragraph and with the aim of finding out the level of recurrence of our visitors and the contents that are most interesting. This way we can concentrate our efforts on improving the most visited areas and make it easier for the user to find what they are looking for.

Statistical or measurement cookies may be owned by Isdin or third parties and you can configure them at any time through the [Cookies Manager](#).

- *Advertising Cookies*

This website also uses behavioural advertising cookies that collect and store information about users' browsing habits and allow the effective management of the advertising spaces that have been included on the website. The purpose is to tailor their content to be relevant to you and to avoid showing adverts you have already seen, as well as to limit the number of advertising impacts we make.

These cookies may be third-party cookies. In these cases, those responsible for cookies may use them to create a profile of your interests and to show you relevant adverts on other sites.

Behavioural advertising cookies may be owned by Isdin or third parties and you can configure them at any time through the [Cookies Manager](#). If you do not agree to the use of these cookies, the advertising you will receive will be less personalised.

#### 4) **How can you disable or delete cookies?**

You can manage acceptance or rejection of cookies through the [Cookies Manager](#).

In addition, we inform you that most browsers allow you to configure your preferences regarding the use of cookies at any time. If you wish, you can set cookies and adjust your browser to reject or delete certain cookies.
